Moreover, the strategy’s returns exceeded the style benchmark for the three latest three-year rolling periods. Products are then selected which have a standard deviation for the five-year period equal or less than the median standard deviation for the peer group. The top ten returns for the latest three-year period then become the 5 Star Top Guns.

Through a combination PSN’s proprietary performance screens, the [PSN Top Guns List](#) ranks products in six proprietary categories in over 75 universes based on continued performance over time.

The Birch Run Intermediate Fixed Income strategy seeks to add value by identifying attractive opportunities in the corporate credit markets through rigorous credit research and a thoughtful analysis of risk and reward. This active approach is further enhanced by the firm’s boutique size, which allows for quick response to ever changing market conditions.
