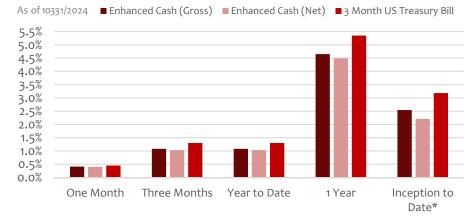

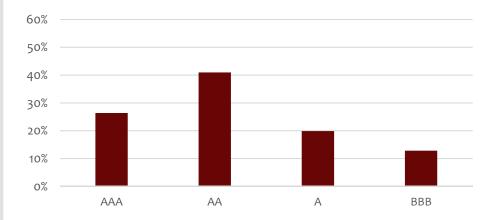

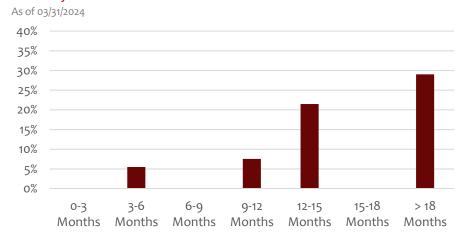

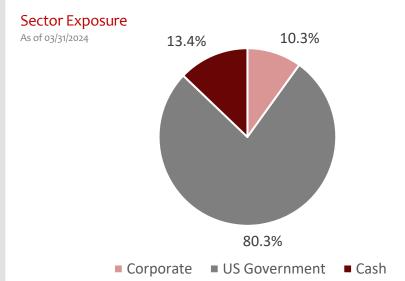

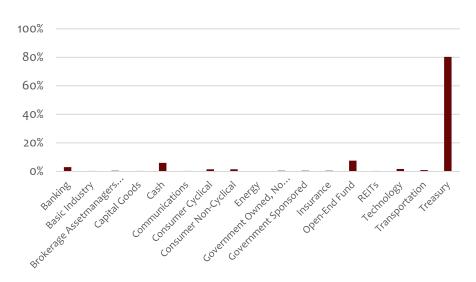
Maturity Distribution
